- All stakeholders and interested parties are invited to attend, however, only owners registered
  as members of the company may vote.
- Per clause 11.9.2 of the Memorandum of Incorporation, no member who is in arrears with payment of the additional rate for more than 60 (sixty) days, shall be entitled to vote at an AGM for so long as s/he is so in arrears except if the member can prove that s/he is in a dispute or has entered into an appropriate payment arrangement with the City or can provide proof of payment.
- Owners wishing to apply for membership should do so by downloading the membership form
  and submitting it to the OBSID office. New membership applications should be received by
  10h00 on 21st October 2020 to be approved and accepted at a meeting of the Board of
  Directors of the Observatory Improvement prior to the AGM.
- Any member may appoint a Proxy to attend the meeting on his/her behalf. Forms of Proxy
  may be downloaded from the website or requested by email. The proxy form must be
  delivered to the offices of the Company no less than 48 hours prior to the advertised time of
  the start of the meeting (by 18h00 on Monday 26th October 2020), failing which it shall not be
  deemed to be valid.
